4. <u>Consideration and Adoption of Resolution No. 2023-04:</u> A resolution of the District Board of the Flagstaff Downtown Business Improvement and Revitalization District (District) adopting the property tax assessments for fiscal year 2023-2024.

Ms. Suda stated that the resolution is the last step in the approval of the budget. The resolution will adopt the tax assessment for the District. The budget is based on a flat revenue which means that they will collect the same amount of taxes as they did in the prior year. Because property values have increased, this translates into a rate reduction.

Member Jerry McLaughlin moved to adopt Resolution No. 2023-04; seconded by Vice Chairman Steve Chatinsky; passed unanimously.

## 5. FDBA Director Report (if needed)

Ms. Madeksza reported that the DBA is well underway with their summer event planning and there are daily events in Heritage Square. She noted that attendance is significantly higher than in prior years which shows that their efforts to bring people into downtown for free family fun is working. The hope is that the increased activity in downtown will correlate with increased sales for the businesses.
